POLICY ON ISSUANCE OF NOTIFICATION LETTER

1. For the Purpose of this Decree, what is meant by:
 - 1.1. Notification Letter of on Going Certification Process (SKP) is a letter issued by LPPOM MUI stating that the product attached to the letter is in the process of halal audit with new registration, development, renewal status.
 - 1.2. Notification Letter of Renewal Certification Process (SKPP) is a letter issued by LPPOM MUI stating that the product attached to the letter is in the process of halal audit in the context of renewing halal certificate.
 - 1.3. Notification Letter of Halal Approval (SKH) is a letter issued by LPPOM MUI stating that the products attached to the letter have been declared halal by Fatwa Commission of MUI.
2. Policy regarding notification letter (This policy changes the previous policy contained in SK47/Dir/LPPOM MUI/XII/14 points 6.a and 6.b)
 - 2.1. Policy related to the issuance of SKP:
 - a. SKP can be issued by LPPOM MUI based on the request of a company and proof of payment certification fee is **provided**.
 - b. The validity period of SKP is three months and may be extended once with the condition that registration has passed pre audit and the company has agreed on arrangement of audit schedule by LPPOM MUI.
 - c. SKP cannot be used as supporting document for halal verification of materials.
 - 2.2. Policy related to the issuance of SKPP:
 - a. SKPP may be issued by LPPOM MUI based on the request of a company under the following conditions:

- materials used in renewal products are approved by LPPOM MUI,
 - there is no change in production facilities, and
 - the company has paid the certification fee.
- b. The validity period of the SKPP is three months and may be renewed once with the condition that registration has passed *pre audit* and the company has agreed on arrangement of audit schedule by LPPOM MUI.
- c. The SKPP can be used as supporting document for halal verification of the materials (for both new and existing materials). (This policy changes the previous policy as set out in SK48/Dir/LPPOM MUI/XII/14 points 1.a).
- 2.3. The Policy related SKH Issuance: SKH is automatically issued by LPPOM MUI for companies whose products have been declared halal by the MUI Fatwa Commission (This policy changes the previous policy as set out in HAS 23 000: 2 points 5.3.a)
